Facts:	The chair lift is used by few of our elderly members to access our lower level which has not been entitled to them previous to getting the lift. Without the chair lift we would have a difficult time getting the ones in need out in event of an incident. The lift has been in use ever since acceptance by Elevator Safety(state permit no. 170215) for about 7 months without incident. This is a private club with members only and not available to the general public.
