There is no space allowed either inside or outside the front door to accommodate the addition of a vestibule. Imposition of this rule would increase development costs as it would force a unique design to the building and require unique equipment, as space is currently otherwise accounted for. Imposition of this rule would disrupt the flow of patron traffic. Casey's patrons are accustomed to the convenience of the floor layout. A vestibule would confuse that routine.
