Conditions: The existing structure is currently on a private well and the non for profit organization does not have the funds available.

The existing structure is roughly a 3,400 sq. ft. finished residential house with (2) stories and a partial basement.

The house will be a shelter for homeless pregnant women. This is not open to the public.

The use will be sporadic, depending on the communities needs.

The maximum served will be 8.

Typically there will be two staff persons in the home except for at night where there will be one staff person who is awake.
