Vehicles will not be re-fueled within the building Up to 60 cars with batteries to be connected, all at one time, starting at 8 am on August 31, 2019 until 11:59 pm September, 6, 2019. Four (4) of the 60 vehicles to be running 5-10 minutes during competitions and show hours of each event day (September 4-6, 2019). Up to 60 cars with ignition in the auxiliary power position, all at one time, during competitions and show hours of each event day (September 4-6, 2019). Vehicles will be secured when not in use. Vehicles will be monitored for any leak, and if any present will be re-located outside immediately.
