Conditions:

The oil separator installed in 2000 in the below-grade parking level of Parking Structure 3 will be removed due to deterioration and not replaced. The 1998 Indiana Building Code required an oil separator to be provided for a floor drain in an enclosed parking garage. Rule 4, Section 9, General Administrative Rules requires existing features required either by current code or the code of record to be maintained.

The lower (basement) level of the 7-story + basement parking structure is classified as an enclosed parking level. The 7 stories above grade are classified as open parking garage.

  2. In the 18+ years since installed, no oil has been observed in the separator.
- 3. The floor drain will be retained, with the existing inlet and outlet connected with the appropriate piping connection.
