Facts: These Rolling fire doors and their operational parts (no longer available) are built into the brick masonry walls. To repair them would require demolishing the brick wall and rebuilding a wall back (on both stories).

Replacement fire door assemblies are estimated at \$9,000 per story which is a major impact on the not-for-profit organization who is paying for a current and long over-due roof replacement.
