Facts:	 A wheelchair space will be provided at each upper floor level landing in each of the 2 stair enclosures. Areas of refuge in stairs or areas of refuge accessing elevators are not required in buildings protected throughout with an automatic sprinkler system. The building comprising floors 2-5 will be protected throughout with an automatic sprinkler system per NFPA 13R. The 1st floor podium structure will be protected with an automatic sprinkler system per NFPA 13. The provision of areas of refuge within stairs will provide an accessible means of egress at least equivalent to an elevator used as an accessible means of egress. The elevators will have battery back-up provided in order to permit lowering of the elevators in the event of loss of power. Additionally, a transfer switch will be provided to permit hookup of a portable generator. This variance was granted under the stated conditions for several previous 5-story buildings, including 16-03-29c, 15-11-29d, and 13-05-36.
