A shaft enclosure will not be provided for the duct penetrating the floor assembly between floors 5 and 6. Code requires any duct penetrations of fire rated floor assemblies in I-2 occupancies be enclosed within a shaft. The duct will be enclosed in a shaft on the 4th floor.

- 4. Similar variances have been granted in the past on other healthcare facilities (17-06-14, 18-02-04, 18-08-29, 19-05-32).
