Facts:	Our Assisted living memory care door has a vinyl decal photo of a cottage with meadow view. The vinyl decal mural does not block or impeded the bar to exit area in any way. We have a CNA staff member and a nurse staff 24/7 and an activity staff member 8 hours 7 days a week. We have 20 beds on the unit with 19 residents occupying units at this time. For safety we have Smoke Detectors in unit that are checked every 6 months, sprinkler system that are visually checked daily, fire extinguishers that are checked monthly, and emergency light/exit lights that are checked monthly.
