Variance Details

Code Name: 1985 Indiana Fire Prevention Code (675 IAC 22-2)

Conditions: So we are housing a shelter in a block built church from the 1800. We have no sprinkler system and need occupancy for more than 30 days. This is only until April 15 and we are only letting 10 guests in per night. We have volunteers each night that stay at all times to watch over the guests. We have many exit doors. We have exit plan. We have smoke

detectors and carbon detectors. The church is lending us the area to house our guests so that they are not out in the cold. We do not have the funding to put a sprinkler system in and this is only temporary for this season as we are looking at a more permanent building for next season. We were given a verbal that we needed to contact the state for a temporary variance for the sprinkler and the more than 30 days occupancy. Shelter open from 5:30 p.m. until 7:00 a.m. then the guests are out for the day.

Facts:

We are only allowing 10 guests per night.

We have the smoke detectors and carbon detectors and the city fire department came in and added a few more for us. We have an emergency exit plan posted and have many doors to exit through.

We have volunteers at all times in the building walking around to keep the guests safe.

We could never cover the cost of the sprinkler system. We do not have the funds to purchase a building until this spring. This is temporary and is from January 3 to April 15.

We would have to put the visitors back out onto the street and the elements.

We have had over 25 come in and we have gotten them into rehab, housing, jobs and apartments or back home to family. As quick as they come in our caseworkers are working to get them to the next step which is out of the shelter into some sort of housing.

Working with the Center Township Trustee who is helping them get housing, jobs or back with family members until we can get housing for them.

Our shelter is not a flop house and we are getting them to the next step towards housing.
