Conditions: THIS IS A RE SUBMISSION OF A PREVIOUSLY APPROVED VARIANCE (19-05-45) FOR PART OF THE SAME WORK WHICH WAS NOT DONE IN 2019. THE PROPOSED WORK HAS NOT CHANGED. BECAUSE OF BUDGET THE ONE PROJECT WAS SPLIT APART AND WAS REFILED UNDER A DIFFERENT PROJECT NUMBER 416552. An existing 1977(c) elementary school will have a small addition and renovation project. Newly created corridors (new administration area, and reconfigure of media, small large group instruction area, creating and infilling with new walls, adding new doors and windows, etc) as part of a this school renovation project will not have rated construction, nor assemblies. The existing school is not protected by an automatic fire suppression system, and the existing corridors are non-rated. Code requires all new work to be constructed as a 1 hour rated corridor, including duct work dampering, with rated assemblies (doors, windows).
